Dear Mr. Zuckerberg,

We are writing to inquire about several of Facebook's policies that affect the safety and welfare of marginalized and vulnerable communities, particularly for individuals and groups who leave religious communities and/or advocate for acceptance of religious dissent within those communities.

In a free and just society, every person must be able to join, change, or leave religious beliefs and communities without fear of retribution. In the United States, the First Amendment to the Constitution guarantees this freedom of and from religion for every individual. Sadly, many individuals experience persecution upon leaving their religion. This persecution can include shame, ostracization, and even violence from their family members and former co-religionists. In many religious communities around the world, "apostasy," the act of leaving one's religion, and lack of belief in a deity are considered to be capital offenses.

This phenomenon has necessitated the existence of support groups to offer support, advice, and, in some cases, protection for ex-religionists. For example, Ex-Muslims of North America (EXMNA) is a nonprofit organization dedicated to erasing the stigma associated with leaving Islam and normalizing dissent in Muslim communities. Due to the threat of ideological violence directed against ex-Muslims, EXMNA is forced to undergo costly and cumbersome security measures to protect the identities of their clients, and to screen for potential security threats among those who request their assistance.

The worldwide availability of online communication is one of the most important tools available to ex-religionists who are forced to hide their beliefs from their proximate communities. According to EXMNA, many former Muslims use private Facebook groups to build relationships with people who have similar experiences. Many of these individuals are fleeing or have fled from credible threats of violence from family members who feel that their decision to leave Islam brings shame on the family. For many of these individuals, organizing online with like-minded peers offers the only real chance to build a community. Facebook groups are an incredibly important venue for them to seek and find social support, including assistance in finding protection from continued harassment and violence.

Despite their importance to geographically far-flung members of ex-religionist communities, Facebook groups are far from an impenetrable haven. Organized religious extremists have realized that they can deny these support groups to vulnerable ex-religionists by co-opting

Facebook's abuse reporting system. As you can see in the attached images, there exist numerous groups whose express purpose is to systematically target and attack atheists and ex-Muslims and their groups on Facebook by falsely "flagging" the relevant pages for "hate speech" or other nonexistent offenses. These attacks are both frequent and effective. Restoring pages that have been removed by Facebook due to these inaccurate reports is a lengthy and cumbersome process, causing many group administrators to abandon Facebook as a communication medium. As support groups often lack any other viable alternative for organizing, this can result in the total dissolution of support networks.

In addition, activists are vulnerable to targeting and harassment in person, including physical violence. This threat often comes from vigilantes but can emanate from government entities as well. In 2017, the government of Pakistan sent mass text messages to the public encouraging them to report any blasphemy they see on social media. In Pakistan, blasphemy and apostasy are criminal offenses punishable by death. Activists have been deterred from communicating on Facebook because the company's pseudonym policies prevent them from safely expressing themselves while protecting their identity.

These problems are extremely concerning, but they are not insurmountable. Facebook can help prevent harassment, persecution, and violence from gaining any traction on its platform. In particular, it can take steps to address the abuse of its reporting system so that these pages and groups cannot be taken down by unscrupulous actors. In addition, it can modify its pseudonym policy to protect the identities of the most vulnerable members of society. Facebook has already modified this policy to protect LGBTQ+ users by allowing users to substitute for their legal name a nickname by which they are known to family and friends. However, the company still requires users to privately confirm their "real" identities. In light of well-organized efforts to track ex-religionists through deceptive means, including by infiltrating sources of personal information, many ex-religionists are understandably cautious about surrendering this information to a third-party organization such as Facebook.

With these concerns in mind, we would greatly appreciate your responses to the following questions:

- What processes does Facebook have in place to prevent abuse of its flagging/reporting system?
- What steps, if any, will Facebook take to protect user accounts who suffer repeated abuse of its flagging/reporting system?
- In particular, does Facebook plan to implement a "white list" of accounts that have been repeatedly targeted by organized user groups for flagging campaigns?
- How many employees has Facebook assigned to review reports of prohibited activity and to identify abuse of its flagging system? Which department at Facebook is responsible for overseeing these reviews?
- Does Facebook plan to take additional measures to protect the identities of users who are targeted for harassment or violence on its platform?

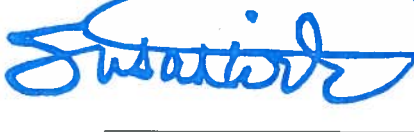

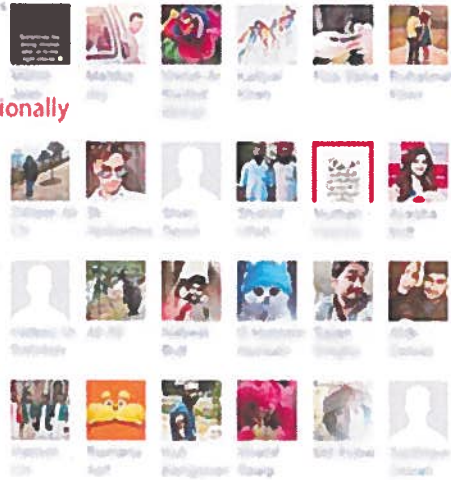
